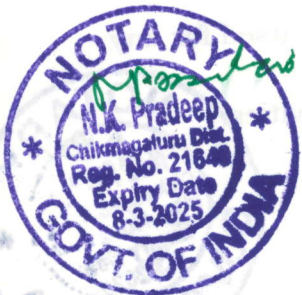

3. Child Rights Education Act Under the regulations framed in 2009, 25% of seats are reserved for children from disadvantaged where the parents of children reside. groups. Reservation. The government has the power to admit seats reserved for RTI under RTI to schools covered under RTI. [The government has rules to facilitate admission in neighboring schools educational institutions funded by the government, admission to that school will be done; in its absence, private schools will enroll and continue education up to primary level with government-provided admissions. Allow these children to study without any discrimination.

4. **Note:** As described in Section 3, the government releases fees for children not admitted under RTI rules as per regulations. Hence, no fees will be collected from these children.

5. The school and the school management board shall not charge any capitation fee or voluntary donations from parents at admission or thereafter in any form.

6. The school/board shall disclose to the state government the information on tuition fees collected from parents. Notification number: department's website. It is not permissible to

8. The school/board should not admit against the following aspects

(II) On the basis of caste, religion, place of birth, language.

10. The school/board shall implement as follows

(I) A child who has gained admission shall not be deprived of primary Until completion of education, in any class, education and medium of instruction at the school, nor expelled.

(II) No child shall be subjected to harassment of physical or mental nature.

(III) Until primary education is completed, any child who completes primary education under any board shall be issued a certificate as per RTI rules.

(IV) Every child completing primary will be issued a certificate as prescribed under RTE rule

(V) As per RTI Act and Rules and Karnataka Education Act and Rules, schools must include special needs / children with special needs as well. " must be accommodated.

(VI) Appointed teachers shall be as per RTI Act and Rules, Karnataka Education Act and Rules, and government orders. Must possess minimum qualifications for primary and secondary school teachers.

(VII) Salaries, allowances, service rules and conditions payable to teachers shall be as indicated by the state government. And salaries will be paid to teachers through the bank and other assets under the government notification [Future Fund (1E)]; and will be covered by employee state insurance (ESI).

24[1] and RTI Act and Rules and Karnataka Education Act and Rules regulations perform the

duties indicated below and for supervisory considerations may engage in private tuitions.

(VIII) Teachers under the Act Section

11. The school follows the integrated State curricular framework and State textbooks.

12. Karnataka Education Act Section As specified in 19, the school shall implement rules and standards. Karnataka Education Act And recruit departmental staff as indicated in the rules.

13. School buildings and other basic facilities related to the school should not be used for any

commercial activities during day or night or for political and non-educational activities.

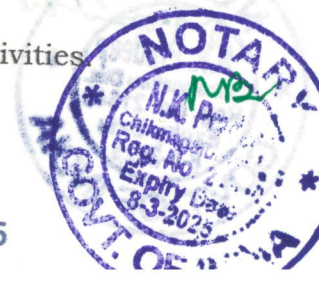

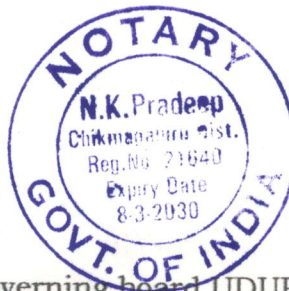


14. The school should not be run for the benefit of any individual, group, or association.

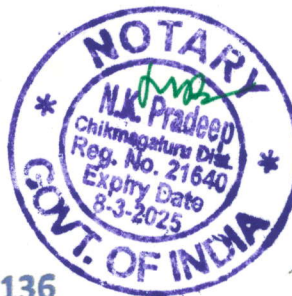
